The Church of St. John the Evangelist Parish of Douglas and Nashwaaksis Annual Meeting – February 23, 2025

The Annual Meeting, chaired by warden Bill MacKenzie, opened at 12:05 pm with prayer led by The Rev. David Peer.

Nomination of Vestry Clerk - Moved by Dennis Williams, seconded by Wayne Knorr, that Carol Jones be nominated as vestry clerk. Carried.

Approval of Annual Meeting Minutes of February 25, 2024 – Moved by Roger Schwartz, seconded by Ruth Lawrence, that the minutes be approved as read. Carried.

Review of Annual Reports

Wardens' Report – no questions

Lay Readers' Report – we now have eight active lay readers, and when we have a new rector, we would like to have some members of the congregation come forward to be trained. No questions.

Cemetery Committee Report – no questions

Chancel Guild Report – New members would be welcome. No questions.

Children's Church Report – thanks to Vivian Osborne and her volunteers for their time and energy in making this a successful ministry.

Willing Wonders Report – a busy year as reported

Martha's Pantry – We have applied for a grant from the diocese to support this ministry. Thanks to Heather Storey, Susan Knorr and Minna Harjapanula, as well as everyone who has donated.

Student Hunger Program 2024 – We have two groups who do this one day per month, preparing a Wednesday lunch for approximately 40 students at Nashwaaksis Memorial School.

Treasurer's Report – Ben Mersereau presented the 2024 report. We ended the year with a surplus of approximately \$29,000, mainly because we were not paying a rector for half a year. Offerings were down about \$12,000 as budgeted for 2024. At the end of the year, we had about \$139,000 in the bank, with \$39,000 being held in trust for refugees. We paid our full diocesan assessment, and we replaced the roof on the stone church. Willing Wonders contributed a large amount toward the gym floor and the boiler repairs. Salaries increased by 3.1% for all staff. Office hours for the office administrator are being increased from 30 to

40 hours per week. Thank you to the auditors, John Baldwin and Roger Schwartz. A copy of the slide of Ben's report is attached. No questions.

Moved by Ben Mersereau, seconded by Roger Schwartz, that the treasurer's report and budget for 2025 be approved. Carried.

Election of Wardens – Bill MacKenzie and Nancy Stephens will let their names stand. Bill asked for any other nominations (three times), and there were none. Moved by Eva Morton, seconded by Rebekah Sears that Bill and Nancy be named wardens. Carried.

Election of Vestry Members – Dennis Williams is stepping away from vestry after many years of service, for which we are thankful.

Moved by Wayne Knorr, seconded by Jeanne Sayre, that vestry remain at nine members. Chase McLean has offered to let his name stand, as well as all remaining members. Bill called for more nominations (three times). Moved by Bill, seconded by Dennis, that the vestry consist of Ben Mersereau, Carol Jones, Donna Price, Jeanne Sayre, Steve Hart, Michael Clark, Joan Dunphy, Heather Storey and Chase McLean. Carried.

Election of Synod Delegates – Moved by Wayne Knorr, seconded by Jeanne Sayre, that Nancy Stephens be a delegate. Moved by Judy Jones, seconded by Eva Morton, that Carol Jones be a delegate. Moved by Wayne Knorr, seconded by Eva Morton, that Bill MacKenzie be an alternate synod delegate. Moved by Stephen Hart, seconded by Jeanne Sayre, that Jeannie Donald be an alternate synod delegate. Moved by Jeanne Sayre, seconded by Judy Jones, that Chase McLean be our youth delegate to synod. All nominations carried.

Appointment of Auditors for 2025 – John Baldwin and Roger Schwartz have agreed to let their names stand. Moved by Judy Jones, seconded by Dennis Williams, that Roger and John be auditors. Carried.

Other Business – Children's Church has been a blessing. We have talked about calling people who are shut-ins, but we will need to comply with the diocesan privacy policy. We will need to decide how to do this and be following the policy.

New Rector – The bishop has not referred anyone to us that he feels is a good fit for our parish. This has been advertised nationally and internationally. Bill explained how the process works.

Questions

Keith Osborne asked if there are any plans for the inside of the stone church now that we have a roof on. Bill explained that there are still repairs that are needed. Contact will be made with the seniors at the Johnston Avenue Seniors' Centre, who could do repairs. The cost to us would be building materials. The roof was leaking, but now that it has been replaced, we shouldn't have as big a problem with mold.

Roger Schwartz asked how we will interact with the neighbourhood once the school has moved to McAdam Avenue, but that will still be part of the “neighbourhood”. We will still provide Wednesday lunches. We have provided teacher appreciation luncheons in the past, and we will probably do so in the future.

Heather Storey commented that with Paul gone, our office administrator, Josh McDorman, has stepped up and provided a lot of support. He is very busy, and Heather asked that we respect the fact that he doesn’t have a lot of time to socialize.

Eva Morton thanked those who have participated in the music ministry.

Moved by Ruth Lawrence that the meeting be adjourned at 12:50 pm. Carried.

Wardens' Report 2025

Scripture tells us that if we seek the Kingdom of God first, then all the things we need will be added to us. When we place God first in life, we see him working through all circumstances and events for our good.

I believe we can see God working through our circumstances here at St. John the Evangelist. We have gone another year without a new full-time Rector, yet we have managed to maintain a strong and active worship community here at St. John's. There are many people to recognize and thank for this.

When we think about what has been going on at St. John's we might think about St. Paul's message in the twelfth chapter of his first letter to Corinthians. In the first part of the Chapter, Paul talks about there being many gifts and people have different gifts. All spiritual gifts come from the Holy Spirit and their purpose is to build up Christ's body, the Church.

In the Second part of the Chapter, Paul compares the Church to a human body. All parts of the body are necessary and connected. The analogy highlights that every part has a specific valuable function and for the body to be complete different parts must work together. The metaphor of the body with different parts is meant to describe the Church as unified body with diverse, yet equally important members. Paul emphasizes the importance of each Church member. We should use the gifts we have been given and encourage others to use theirs.

We never really fully recovered from Covid before losing our Rector. It is because so many people have been contributing their spiritual gifts that we have been able to maintain a strong and active worship community.

We are blessed to have three honorary assistants officiating Sunday services. I am sure I express our shared gratitude in thanking Rev. Canon Bruce McKenna, Rev. Canon David Peer and Rev. Canon Keith Osborne. They not only officiate Sunday services, but they have also been leading book studies, training new lay readers, doing interments and pastoral care. I am sure I have not thought to list everything, but we are grateful for it all.

There are many others that make our worship service work. The Chancel Guild prepares the altar. The lay readers assist the clergy. The music leaders and choir lead us in song. The prayer team pray for those who stop by the Prayer Corner during communion. The Children's Church leaders provide activities for the children that teach the children the gospel message through stories and activities. Rick, Brenley and Doug interpret the Gospel through a puppet show that is enjoyed by the adults as well as the children. The AV team enable us to live-stream the 8:30 service and to follow the 10:30 service on the screen.

The Willing Wonders take on many activities that make our fellowship more enjoyable. They support church community meals, organize the bazaar and other fund raisers. Their fund -raising efforts contribute to enriching our church life.

We are thankful for the continued service of Josh McDorman and Darrell Jones and how they keep St. John's running smoothly. Please remember in your prayers our staff and all the volunteers who enrich life here at St. John the Evangelist. Our Parish continues to be enriched by the activities of our many volunteers including music leaders, lay readers, children's church leaders, Chancel Guild, greeters and counters, Bible study leaders, Willing Wonders, Vestry and all those who pitch in when asked. Thank you for all that you do.

As we begin 2026, the new year will bring us new challenges and blessings as we live out our Church Mission. Hopefully it will bring us a new Rector too. Our mission as a Parish is to enthusiastically worship and serve God so that the needs of the parish family and community find fulfillment in Jesus Christ.

Willing Wonders Report 2025

Our most important work is through the Pantry – organized and planned by Heather Storey and her teams. The Pantry is open to any people needing help with groceries on the second and fourth Tuesdays of each month. Many parishioners supply this Pantry. Extra needs for the Pantry are usually published in the church bulletins.

The Willing Wonders kitchen crew met four times in 2025 to plan for each event. We had a spring bake sale and a yard sale including book, plants and bake sale. In the fall, we had a bake sale, followed by the Bazaar on November 23rd. With our funds, we assisted with payment for the boiler repairs, contributed to the Minister's Discretionary Fund, help with Christmas boxes for the "Under the Tent" ministry meeting at our church, and contributed to the Farralane Home fundraiser (an Anglican retirement facility in Fredericton). We helped the Nashwaaksis Baptist Church to cater a lunch for the teachers in appreciation of their work at Naswaaksis Memorial School. This ministry has been replaced with a supply of fruit, once a month, to the new Sunset Acres School on McAdam Avenue.

In 2025 we provided a funeral reception required by the members of our congregation.

Once again, we thank the many creative, giving people at St. John's. They are willing to donate and willing to help us whenever asked. We are blessed to be able to give of our time.

We didn't have many homeless people this past year; most are single and in their sixties to seventies, but we do have five families.

Due to Bill applying and us receiving a grant from the Diocese of \$2,500 we have been able to share our good fortune with our friends. We try once a month to provide one of the following as a treat, fresh fruit, vegetables, eggs, and even meat once in a while if we can get a good deal. Susan Knorr is great at getting the meat deals. Without Susan, Minna, and Jeanne this operation couldn't flourish as it does. Darrell keeps us supplied with hot tea and coffee to enjoy with our muffins and other goodies.

We have all learned so much from our friends, the hugs, smiles and yes at times a few tears. We have stood in a circle and prayed and had people ask us to add their loved ones to our prayer list. This is partly what we hoped to accomplish with the Pantry. Food is essential and there is always a need, but the friendship and fellowship is a bonus we all treasure.

I have had some of you ask what we need, and I'll put a few essentials here for you. These are the things that we use the most. Ketchup, mayonnaise, juice, jam, cheese whiz, toilet paper and Kleenex these are the items we go through each Pantry day. As I tell everyone who asks, the size is not important and please buy what's on sale. We are all on a fixed income whether we're still working or not. Thank you all once again for your donations and interest in this important part of our outreach program here at St. Johns. It's more than just the ones who are here every second week, it takes a congregation to keep this going. God Bless you all.

Under the Tent Annual Report 2025

St. John's continues to host the Under the Tent street ministry every Wednesday afternoon from 2 - 5 o'clock. And even though one of those days last year was Christmas Eve, we still managed to offer some hospitality to our regulars. One of our volunteers even said it was one of the best Christmases he'd ever had.

We have a kind and generous group of about twelve volunteers, who come and supply treat bags, a hot meal, coffee, hot chocolate, muffins, cookies, and whatever food donations we've received that day. In winter we supply hand and foot warmers, as well. We also offer the opportunity to take a shower or do some laundry, and we give out bus tickets.

We provide a selection of donated clothing, blankets, tents, backpacks, sleeping bags, etc. Items of clothing are always quickly snapped up, especially outdoor wear in the winter. Things that are often sought: sleeping bags, backpacks, warm coats, blankets, snow pants, and boots. Toiletries are always gratefully received, as well as clean socks and underwear. Every week is different, depending on what we receive. We are very grateful for the donations we receive. The parish now has a lot more towels than we did before!

Many of our street friends arrive promptly at 2 o'clock and stay right up until closing time. They often pitch in and help sweep the floor and tidy up. It's not just shelter from the weather, but an opportunity to sit and socialize without having to be vigilant about protecting their possessions or being scrutinized or harassed and forced to be constantly on the move. How nice for them to just sit and relax for a couple of hours! Most of them know one another and look forward to re-connecting every week.

At present, our average attendance is around 35, but in the summer it was nearly 50. We don't always have the same people every week, so the total of those we have been helping is actually more than that. Over the last year we've met some new people, and because of weather and living arrangements numbers have been lower in the last few weeks. Some of our regulars were able to get housing, for which we are very thankful.

This is a quote from Mary Jo Roy, who co-ordinates the Wednesday gathering: "Because of the church space and the comfort our friends feel with just sitting and relaxing, Bill (McLaughlin) has been able to have some conversations and offer advice on how UTT can help them with changing their lifestyle if they so wish."

We've had a few new volunteers join us in the last year, and they've become regular supporters, for which we're very grateful. If one of us gets sick, or has to be away, it's good to know there are others there to pick up the slack. We've had some of our street friends attend worship services from time to time, and one who has become a parishioner. Their gratitude for what we offer is heartwarming.

I want to express my thanks to the parish for its ongoing support. I have been blessed by my involvement in the Under the Tent ministry, and I know we are making a difference in many lives.

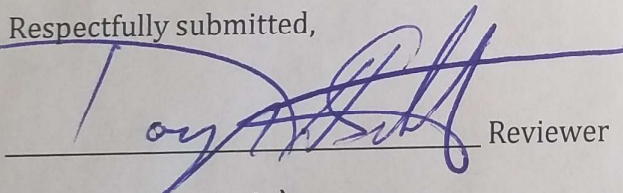

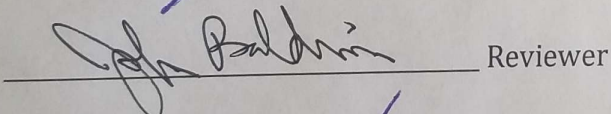
